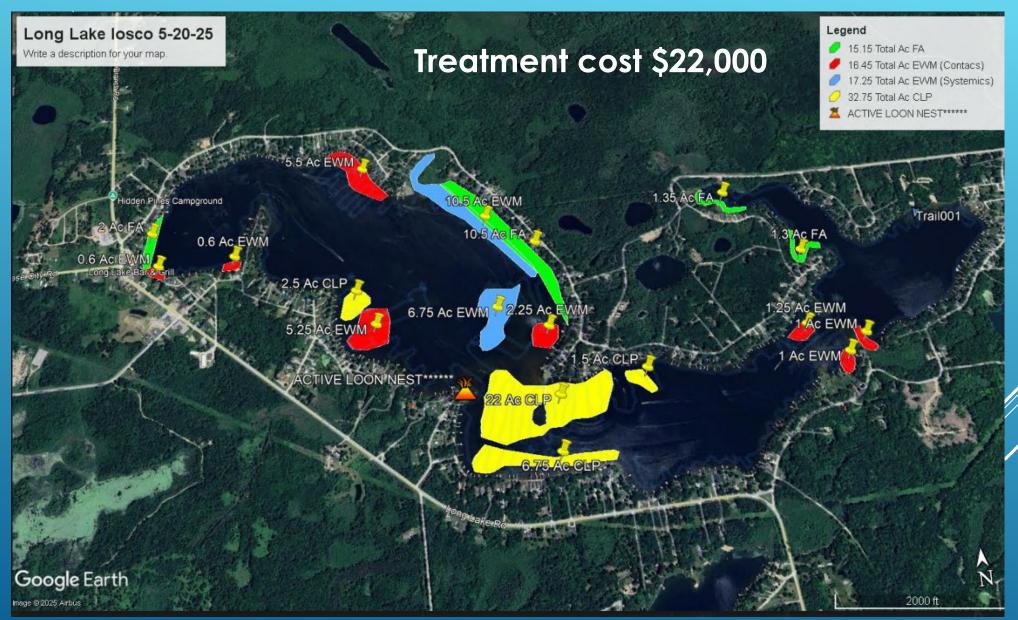

Special Assessment Update

Special Assessment for Weed Control – (SAD) – reduced for 2025

- 2025 weed control assessment lowered to \$89.64 by the township board (from \$111)
- Current balance is \$39,570 as of 6/30/2025
- We continue to monitor costs to ensure proper treatment while being fiscally responsible
- We have sufficient funds for this year but run the risk of potential shortfalls as soon as next year.
- The board is requesting support for a resolution to request that the township board increase the special assessment by 5%, about \$4.50 per parcel.
